09:50 – 11:00	<i>Panel Session</i>	<p>Content regulation and standards</p> <p><i>There has been a significant recent increase in debate around a wide variety of online harms, ranging from fake news and online safety to cyber bullying and radicalisation. This includes who should bear responsibility, the respective roles policymakers, industry and users should play, and whether the overall regulatory framework is fit for purpose. A Parliamentary Committee inquiry is currently investigating whether to 'regulate the Internet' and a Government White Paper on online harms is currently determining the scale of the challenge and what response is required.</i></p> <p><i>Similar discussions are taking place around the globe after more than two decades of action from policymakers, industry, charities and others to make the online environment safer.
